77/17 To receive External Audit Report and approve actions

Clerk advised council that external audit report had been returned with no issues. Clerk was thanked. **Resolved.**

78/17 To consider and approve response to Planning applications:

- a) S/2017/2503/FUL & S/2017/2504/LBC Remove fireplace to reveal original fireplace, install chimney liner and re-instate chimney pot. Remove internal arch and studwork in hallway/porch. - The Old School 12 Cross Tree Road
 No objections
- b) S/2017/2495/LDE Certificate of Lawfulness for existing development comprising of the conversion and extension of an outbuilding to form an ancillary dwelling and an existing garage/workshop and home office. - Keepers Cottage Wicken Road No objections
- c) S/2017/2623/FUL Proposed 2 Storey, 3 Bedroom House Land North Of 1 Quarry Green Close

Council objected to this application. It was felt that this was out of character and would spoil the street scene at the entrance to the village. Other houses here are lower and not so visible as this one would be. There were also safety concerns for those wishing to turn onto Deanshanger Road from Quarry Green Close as it was thought the house could be an obstruction to view.

79/17 To consider and approve response to Northamptonshire County Council 2018/19 budget: Phase 1

Northampton County Council are proposing many changes to their services to save money. Parish Council felt the ones they would like to comment on as they would be missed were:

- 1- The potential loss of the no.90 bus service to Wicken.
- 2- Parish Enhancement Gang
- 3- Road Marking Reduction.

Clerk to respond to Consultation accordingly. Resolved.

80/17 To consider and approve recommendations from Solar Farm Committee

- 1 last meeting £400 was approved for Wicken News. It was proposed to increase this to £600 for this year and next year. There was a discussion about content vs. advertising. Proposal approved.
- 2 A new village website is needed. It was proposed that up to £2000 be used for set up and approximately £100 £500 per year hosting. Proposal approved
- 3 Proposal for updating of street lights. This needs investigation and it was proposed that £12000 be put aside for the project to employ a contractor for advice and for the work to be completed. It was approved that the funds would be reserved but full information is needed before funds are released.
- 4 There are plans for new play equipment, the majority of which will be funded by New Homes Bonus fund, but there may be a need for this to be topped up from the Solar Farm fund. Cllr Edmonson to report back with full costings at a later meeting.
- 5 Church had requested funds for churchyard maintenance but the committee would prefer capital projects so the church are requesting match funding for new heating at the church. This would be approximately £10k £12k. This had not been put past the Committee but the Parish Council were keen to approve.

There were other projects that were noted that need more information before any approvals.

81/17 To receive update on Solar Farm screening issue

Resident had commented that planting to screen solar farm from the village is not being maintained and there is concern that as such this will die. Clerk has contacted the owners, but no response. South Northants Council have also been contacted and an enforcement Officer has been allocated to look at this.

82/17 To receive update on Western Power remedial work and discuss any concerns

Councillors commented on good workmanship of contractors, however concern was raised that extra soil has not been taken away (due to the pipes being added) and that the verges are higher, also that grips to the ditch are no longer there, and the ditch is part filled. The concern is that this means that there will be a lot of surface water if heavy rain. Cllr Ivens to take a look and follow up with Western Power if needed.

83/17 To receive update on SNC Local Plan Part 2 and Loan Programme status

Response to Consultation was circulated and agreed. Clerk to respond.
