46/18 To consider extra VAS pole on Wicken Park Road.

It was initially thought that an existing pole opposite Sparrow Lodge Farm could be used but it would be too low. Depending on costs we may be able to install our own pole. **Resolved.**

47/18 To consider what to do about potholes in the curtilage of the village

Street Doctor is not very responsive on pot holes. It was wondered if we could do this ourselves, but anyone who would be able to do it would need permission from NCC. It was agreed to speak to Highways to see what can be done

48/18 to discuss Wicken Wood and possible loss of habitiats

There are rare butterflies in Wicken wood. There have been workmen in there and there is concern that the habitat would be destroyed. A meeting is being arranged

49/18 To receive update on Street Lighting

The initial discussion with the consultant suggests that a more formal report would be needed from a party that would be able to do the work. One quote was £2850 + VAT. There is currently investigation into types of lights and whether planning permission would be required. Solar Farm committee to consider and make a recommendation.

50/18 To consider and approve response to consultation on local government reorganization in Northamptonshire

It was proposed that a draft response is circulated by the clerk for comment and response by email by the councillors.
